Source Monitoring

Compliance Requirements Lists - Updated Regulations (Monthly)

1. We check if there is a new amended version of the listed Canada regulations/requirements each month.
2. When a new amended version is found, we rewrite the CRL entry and update the database.

Project modules

The project module sources are not actively monitored on a monthly basis.

Notes

1. We only monitor amended versions as they are published on the Justice Laws Website ([Link](#)) for the listed regulations. We only check sources monthly, which means that there is a delay from the publication of a new amended version until the point that we include it in the monthly report and also update affected CRL entries.
2. We do not track amendments, proposals, or other news announced on the Government of Canada Website (e.g. Justice Laws Website, Canada Gazette publications) related to covered regulations

Compliance Requirements Lists - New Regulations (Monthly)

1. We monitor new regulations announced in the Canada Gazette publications ([Link](#))
2. We select regulations that we find and deem relevant to the product categories we cover.
3. This can, in turn, result in new CRL entries and new document templates.

Project modules

1. We review the project module entries to determine if these can be improved.
2. We may update the project module entries if we are aware of updates to the regulation or subject that these are based on. Note that the project modules do not necessarily cover all steps/requirements under a particular regulation or set of regulations. As such, it is not certain that a new version of a regulation or set of regulations will result in updates to the project modules.

Document / label templates

1. Is there a **newer version** of the regulation/guidance page that the template is based on?
2. If **yes**, update the template (even if the particular article/annex/regulation/part is the same) and specify the new source version
3. If **no**, do not update the template

Monthly Testing

Compliance Requirements List

The purpose of this test is to verify if all selected entries (country, product categories, and specifications) appear correctly in the compliance requirements lists:

1: We create a compliance requirements list with **5 modules** (selected from the first row) for each country/market (US, EU, UK, and Canada)*

*The following 5 consecutive modules are selected in the following month.

2: We select "Yes" for all specifications

3: We check that all entries appear on the product page

4: We check that all entries appear on the PDF report

Document templates

The purpose of this test is to verify if document templates function correctly, and if the template fields and downloaded PDF files contain the correct text.

1: We create **1 new document** (selected starting from the top left) and download it in PDF format for each country/market (US, EU, UK, and Canada)*

*The following template is selected in the following month.

2: We fill in additional headlines, one subheadline for each headline, and add all images (where possible), and download the document in PDF format

3: We check that all the information is present in the PDF file, and that it matches the information in the template page

4: We check that the headlines in the template page match the headlines in this document (see above Document templates database)

5: We check that the sidebar is showing the information concerning the relevant template

6: We reset the document to confirm that the reset functionality is working correctly

7: We delete the document to confirm that the delete functionality is working correctly

8: We open and download a pre-filled document for each of the available templates to:

- Check that the sidebar is showing the information concerning the relevant template
- Download a PDF and check that its text/images match the text/images entered in the template

Label templates

The purpose of this test is to verify if label templates function correctly, and if the template fields and downloaded PDF files contain the correct text.

1: We create **1 new label** (selected starting from the top left) and download it in PDF format for each country/market (US, EU, UK, and Canada)*

*The following template is selected in the following month.

2: We fill in all text fields, add all images, and download the document in PDF format

3: We check that all the information is present in the PDF file, and that it matches the information in the template page

4: We check that the sidebar is showing the information concerning the relevant template

5: We reset the document to confirm that the reset functionality is working correctly

6: We delete the document to confirm that the delete functionality is working correctly

7: We open and download a pre-filled document for each of the available templates to:

- Check that the sidebar is showing the information concerning the relevant template
- Download a PDF and check that its text/images match the text/images entered in the template

Source link monitoring

1: All source links that can be found inside compliance requirements list entries/items and templates are available on a specific table of the Compliance Gate Platform database.

2: A copy of the table is uploaded to a separate website.

3: The links are scanned by a plugin titled Broken Link Checker. This plugin provides a list of:

- 404: Broken URLs (page removed)
- 301/302/307: Redirected URLs

4: We take the following action in case any of the above is detected:

- 404: We replace the source link
- 301/302/307: We assess if the new page is relevant*

*If yes, then we update to the current (redirected) source link. If not, then we replace the source link.

5: There are some scenarios in which a missing, incorrect, or irrelevant source link could be present in the compliance requirements list entries or templates:

- Plugin fails to detect 404/301/302/307
- Content changed on page (but no 404/301/302/307)

There is also a risk of human error, resulting in missing, incorrect, or irrelevant source links not being replaced.
